## Licences:

- Valid registration from relevant government authorities/bodies such us:
  - Minister of Commerce and Industry.
  - Ministry of Public Works
  - Lasanod Municipality
- **Tax compliance certificate:** A valid tax compliance certificate (TIN) from Lasanod local revenue authority.
- **Proof/evidence of company ownership:** all contractors shall submit a signed public notary document stating the ownership of the company including names, positions/titles, contacts details and shares owned. **Note:** Failure to submit all above licences will lead to automatic disqualification.
- Previous similar works experience in construction works: Shall submit ONLY 3 previous similar infrastructural civil construction related contracts implemented with and/or for government institutions, International non-governmental organizations (INGOs) or UN agencies in the last 7 years. Note: Forged contracts will lead automatic disqualification.
